5. Sealed bids must be submitted to the office Department of Industry Kathmandu Kathmandu by hand or through e-GP system i.e www.bopatra.gov.np/egp on or before 19-06-2026 23:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 22-06-2026 11:00 at the office of Department of Industry Kathmandu Kathmandu Bagmati Province Nepal.
Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 40000 , which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[1700100102030000] at [Rastriya Banijya Bank Ltd. , Lalitpur , 0, Kathmandu, Bagmati Province, Kathmandu] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission
